3. developing situational awareness and self-defence skills can help you protect women in any situation.

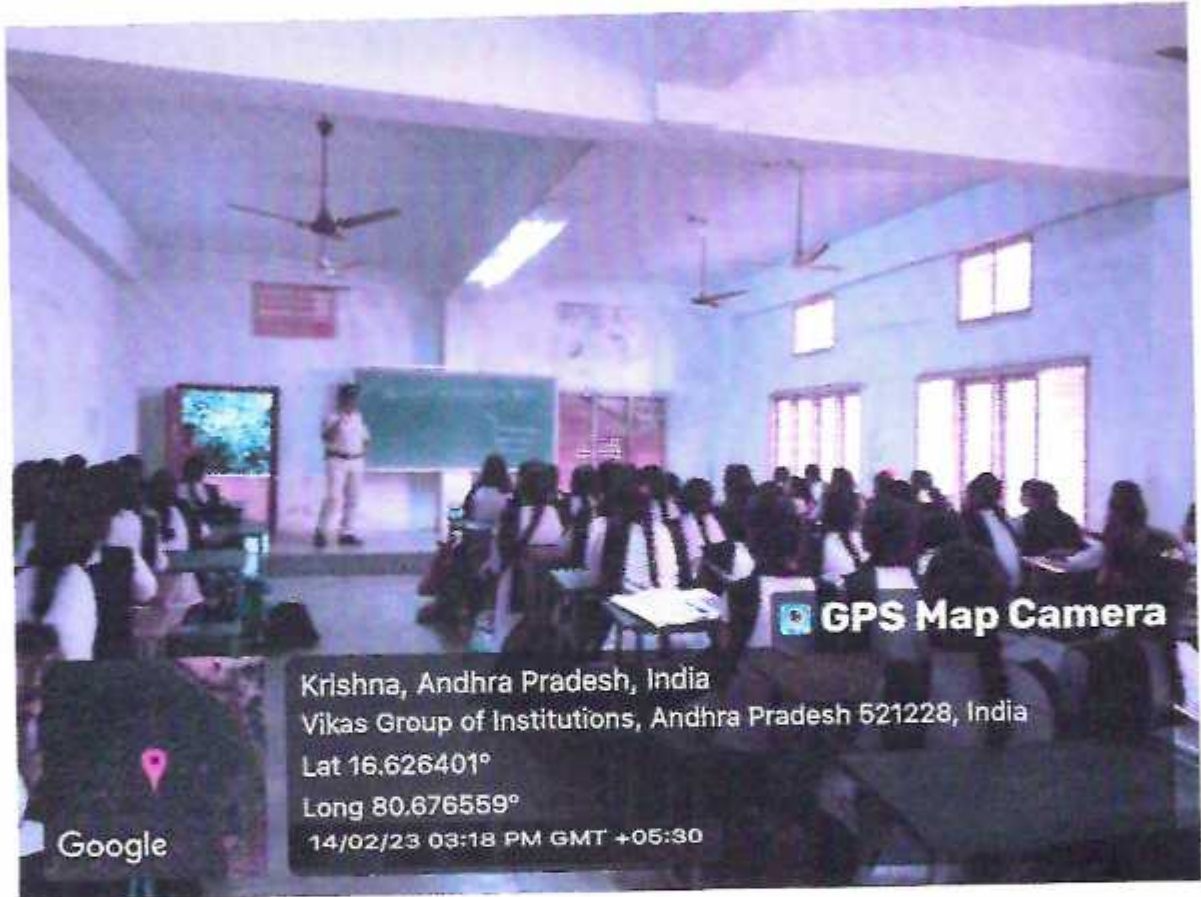

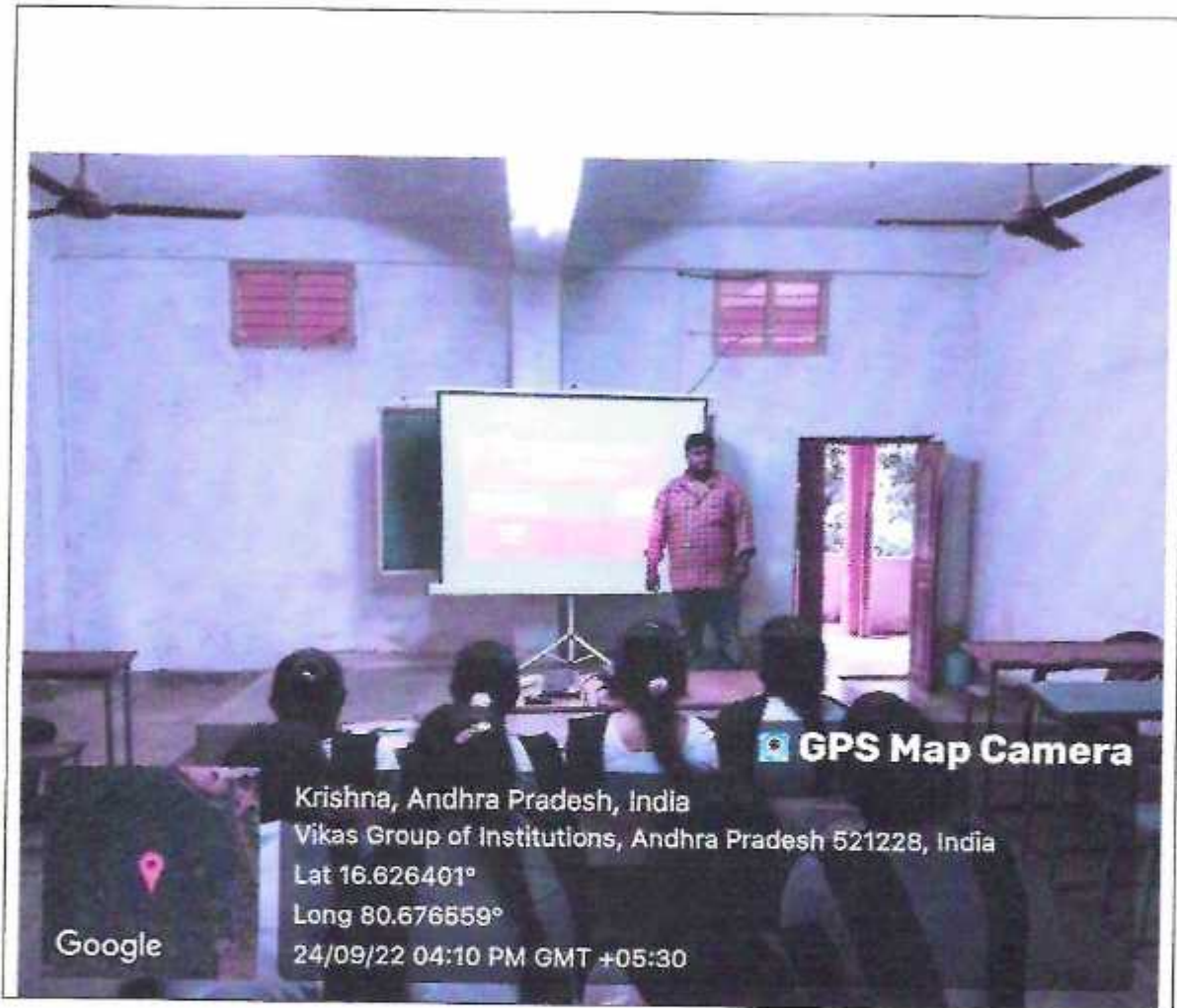


