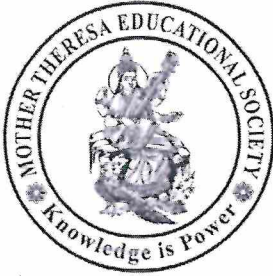

### Introduction:

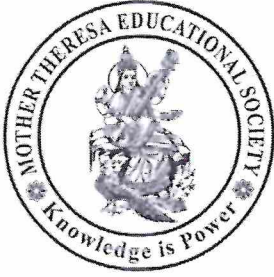

## Scholarship Details:

- **Slots:** Available for all postgraduate (PG) students.
- **Tenure:** The scholarship lasts for two years.
- **Amount:** An amount of Rs. 5000/- per candidate per year.
- **Eligibility:** Open to PG degree-seeking students only.
- **Age Limit:** Applicants must be under 30 years old at the time of admission to the PG course.
- **Exclusions:** Distance education programs are not eligible under this scheme.

## Joining:

- The scholarship begins from the date the student joins the first year of their PG course, as indicated in their online application and verified by the Institute.

## Disbursement of Scholarship:

- Payment is made via Direct Benefit Transfer (DBT) mode.
- Payments are made monthly for the duration of the PG course.

## Renewals:

- Scholarships are renewed throughout the PG course duration, contingent upon good conduct and meeting attendance requirements.
- Renewal requires submission of a renewal form.
- Non-promotion to the next academic year leads to forfeiture of the scholarship.
- Changing the course of study is not permitted.

## Cancellation of Scholarship:

- Scholarship may be canceled if there's misconduct reported by the Institution.
- Unsatisfactory academic progress, scoring less than 50% marks in the first year of the Master's program, can lead to cancellation.
