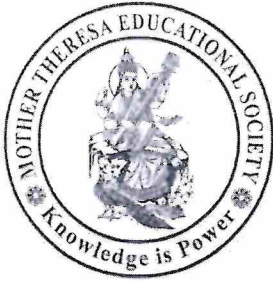

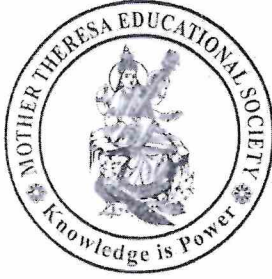
INTRODUCTION:

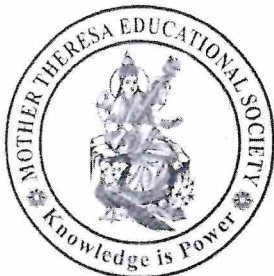

ELIGIBILITY:

- Regular teaching faculty members of the institute are eligible for financial assistance to attend Faculty Development Programs (FDPs), engage in research activities, participate in seminars, workshops, conferences, and symposia related to the field of education at the state, national, and international levels.
- Teaching staff who utilize the physical facilities and financial aid provided by the institute are supported in completing their Ph.D. programs within the designated timeframe.
- Upon obtaining their doctoral degree, faculty members are required to remain affiliated with the same Institution for a minimum period of three years.
- Financial support is extended to faculty members for research projects and publications published in renowned journals such as SCOPUS, Web of Science, and SCI-indexed journals.

PROCEDURE OF APPLYING FOR THE SCHEME:

- Faculty members desiring financial aid for their Ph.D. pursuits are required to submit a Financial Support Request Letter, which necessitates approval from the principal.
- Teachers seeking financial assistance for attending Faculty Development Programs (FDPs), research works, conferences, workshops, seminars, symposia, or obtaining professional memberships must obtain prior permission from the principal. Subsequently, they should submit relevant documents, including registration receipts,
